### **SERVICE SEMINAR INFORMATION**

#### **PURPOSE**

A basic introduction into EEG will also be presented.

The **IOM/EMG** seminar will also cover operation, system configuration (standard and optional) both software and hardware, block diagram signal flow analysis, symptom analysis troubleshooting techniques and disassembly. A basic introduction to IOM/EEG will also be presented.

#### ***New IT Seminar***

The Seminar for IT Professionals will focus on the needs of the EEG-1200 and 9000 series systems from a Domain operational standpoint. This course will discuss SQL database operations and installation, Domain permissions and access rights for users and storage, Active Directory operations and requirements, Client installation and configuration, Remote access (VPN, RDP, Citrix) requirements, symptom analysis and troubleshooting. A basic introduction to EEG will also be presented.
